Ocean Governance

Enhancing Vanuatu's National Capacity for Sustainable Development

In an effort to strengthen environmental governance in Vanuatu, a <u>workshop on Environmental Impact</u> <u>Assessment (EIA) and development permitting processes</u> took place from July 1 to 5, 2024 in Port Vila. This training was organized by SPREP and Vanuatu's Department of Environmental Protection and Conservation, with support from the ACP MEAs III programme and other sources. The event focused on improving inter-agency coordination and environmental assessment capabilities. Over 40 participants, including government officials and NGOs, engaged in discussions and practical exercises to enhance their understanding of EIA, GIS applications, and sustainable development strategies.



The Nairobi Convention Strengthens its Strategy Ahead of COP11

In the efforts to fulfil its mandate of protecting, managing and developing the coastal and marine environment of the Western Indian Ocean (WIO), the Nairobi Convention is implementing and strengthening its strategies and action plans:

- For several years, the Convention has been implementing the <u>Western Indian Strategic Action</u> <u>Programme (WIOSAP)</u> to protect the region from land-based pollution, which includes a project
- on marine litter in Zanzibar funded by the ACP MEAs III programme.
- After two years of work, a 24-member multistakeholder task force has drafted a <u>Regional</u> <u>Ocean Governance Strategy (ROGS)</u> for the WIO.

A discussion of the progress made in the implementation of the WIOSAP and a presentation of the draft ROGS are part of the agenda of the eleventh Conference of the Parties (COP11) of the convention, which will be held from August 20 to 22 in Antananarivo, Madagascar.



Ethiopia hosts Africa Blue Economy Week, highlighting marine sustainability.

The <u>Africa Blue Economy Week</u> was held from July 23 to 25 in Addis Ababa, Ethiopia, under the theme *"Empowering Africa's Blue Renaissance"*. This event was organized by the African Union in partnership with UNDP, and it highlighted the significance of the continent's blue economy potential, focusing on sustainable ocean resources management. The event featured discussions on policy frameworks, innovative practices, and investment opportunities aimed at harnessing Africa's marine and coastal resources. Stakeholders from various sectors, including governments, businesses, and civil society, came together to explore strategies for sustainable development and economic growth within the blue economy sector. Biodiversity

The Open-Ended Working Group on Digital Sequence Information will meet ahead of CBD's COP16

From 12th to 14th August 2024, the second meeting of the Ad Hoc Open-ended Working Group on Benefit-sharing from the Use of Digital Sequence Information on Genetic Resources (WGDSI-2) will meet in Montreal, Canada for final negotiations before the matter comes up for decision at the UN Biodiversity Conference (COP 16) in October, in Cali, Colombia. Agreement is needed on several questions, including which industrial sectors using DSI should share its benefits. Top candidates include pharmaceutical, cosmetics and agriculture.

The meeting will also develop further the proposal of the multilateral mechanism for benefit-sharing from the use of digital sequence information on genetic resources, including a global fund. This will be done based on the meeting documents and will be an important part of the recommendations to the Conference of the Parties for consideration at its sixteenth meeting. Prior to the meeting, the CBD Secretariat has released the proposals that will form basis for the negotiations. More details can be found on this <u>press release</u> from CBD.



Key outcomes from CITES Animals and Plants Committees Meetings

From 8th to 13th July 2024, the 27th meeting of the Plants Committee (PC27) of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) convened exchange information, provide guidance and make recommendations on the conservation priorities of plant species in international trade. The Committee agreed on several draft decisions for CITES Parties, which outline specific actions, recommendations, or directives on scientific and technical matters for consideration at the next CITES Conference of the Parties (CoP20) in 2025.

The 33rd Meeting of the Animals Committee took place from July 15 to 19, 2024 with an aim of discussing the status in international trade of African carnivores, pangolins, sharks, amphibians, songbirds, and marine ornamental fishes, among other species. CBD appoints new Executive Secretary

On July 1, 2024, Astrid Schomaker of Germany has officially assumed the role of Executive Secretary of the Convention on Biological Diversity (CBD) in Montreal. With a strong background in international relations and global environmental policy, Schomaker takes charge ahead of the sixteenth meeting of the CBD's 196 Parties (COP 16) in October 2024. UN Secretary-General António Guterres appointed Ms. Schomaker in April 2024, recognizing her extensive experience, including her recent position as Director for Green Diplomacy and Multilateralism at the European Commission. Schomaker aims to advance the implementation of the Kunming-Montreal Global Biodiversity Framework. More details can be found on this press release from CBD



Chemicals and Waste

Vanuatu Steps Forward to Curb Plastic Pollution

In response to the challenges posed by plastic pollution, <u>the government of Vanuatu has been</u> <u>implementing innovative policies</u>, starting from 2018 with a ban on certain single-use plastics, including a world-first ban on plastic straws. The nation has successfully decreased plastic waste by replacing items like plastic bags and polystyrene containers with reusable alternatives. Supported by SPREP and other stakeholders, <u>the country is now focusing on designing a Product</u> <u>Stewardship Scheme to manage beverage containers</u>, aiming to further reduce plastic litter and enhance sustainability



Barbados Launches New Plan to Tackle Plastic Pollution

In a reflection of its commitment to environmental conservation, the <u>government of Barbados has</u> <u>unveiled its National Action Plan</u> to combat plastic pollution, aiming to protect its marine environment and promote sustainability. The plan focuses on reducing plastic waste through improved waste management systems, increased recycling efforts, and public education campaigns. By addressing both the sources and impacts of plastic pollution, Barbados hopes to safeguard its natural resources and support a cleaner, healthier future for its citizens and marine life
